I always carry my camera as there is a high concentration of a large number of species which are habituated to the presence of people and always present close range photo opportunities. From 2006 when I obtained my first digital camera, I have maintained a photographic record of the species which live on the lake, breed at the lake, feed at the lake or just drink at the lake. People are familiar with the ducks, pelicans and ibis, and over the years, I have photographed at the lake, Cormorants (2 species), grebes (2 species), spoonbills, masked plovers, herons (3 species), egrets, native ducks, reed warblers, martins, blue wrens, honeyeaters (3 species), wattle birds, coots, swamphens, rainbow lorikeets, green lorikeets, black swans, ravens, long necked tortoises, silver gulls, Pacific gulls and hawks (2 species). A surprising number of species, which I have underlined, have actually bred at the lake. What is more this list of species is by no means a comprehensive record of species which interact with the lake. What I particularly love about Freshwater Lake is that it is clearly important in the conservation of wildlife and at the same time is a community asset, both for recreation and as an educational tool. It is disappointing to learn the discharge of water from Freshwater Lake into the West Lakes saltwater lake is no longer allowed. This prevents the expulsion of excess salt, nitrates and phosphates from the lake and I believe is a key factor in the deterioration of the water quality. Over coming these problems will go a long way towards restoring the lake to its former glory.
