

1. BACKGROUND

The condition of the roadway, paths and kerb & gutter in Thirteenth Street and Market Place are at the end their life. Both streets were placed on Council's long-term road program for rehabilitation.

When we plan for road projects, we also investigate current and potential future transport demand within the local street and surrounding network to determine what improvements can be made to ensure that the road can operate as safely and as efficiently as possible.

A review of the traffic and walking connections was undertaken and in 2021 Council received a petition for the inclusion of additional street trees in Market Place and Thirteenth Street.

2. COMMUNITY ENGAGEMENT APPROACH

This project is a matter set out in Part 3 of Council's Public Consultation Policy and, accordingly, the public consultation steps for this project have been determined by Council on a discretionary basis.

2.1 Engagement Objectives

The purpose of engagement with the community for this project is to:

- Ensure public awareness of the proposal and access to appropriate and relevant information.
- Provide opportunity for our community and the interested public to provide feedback on the proposal.

2.2 Engagement Process

The community engagement was set out across two Stages.

We provided the opportunity for feedback through:

- Local community WALKshop (street walk)
- an online feedback form on Your Say Charles Sturt website
- Hard copy feedback form

The engagement was communicated through:

- a coloured brochure distributed into letterboxes to the local area (Fig 1), including owners not residing at the properties.
- YourSay online website page


Stage 1 - Issues & Opportunities (December 2021)

Prior to designing the concept plans we invited the local residents to come along to a street meeting on Tuesday 14 December 2021 (5pm to 6pm), where we walked Market and Thirteenth Street to understand the views on some of the elements in the street, including the garden bed in Market Place.

Stage 2 - Concept Plan Stage (July/August 2022)

A concept plan was developed based on the conversation from the street meeting in December 2021. We consulted on the concept in July/August 2022.

Project Overview

Market Place and Thirteenth Street in Bowden is listed for road rehabilitation in our road program for this current financial year.

In December 2021, we met with residents to discuss any issues or opportunities regarding the existing landscaped garden, alignment of the roadway and the general condition of the street. Since that time, we have also received a petition for the inclusion of street trees in Market Place and Thirteenth Street.

Based on what we heard from you, a detailed concept plan has been developed and we would now like to hear your thoughts.

The road rehabilitation and streetscape improvement project includes the following initiatives.

- Replacement of all kerb and gutter
 Replacement of all kerb and gutter







4. ENGAGEMENT FEEDBACK


4.1 Issues & Opportunities

During our WALKshop on 14 December 2021, we had approximately 5 residents in attendance. Walking the street to discuss the proposed path alignment from Hawker Street to Thirteenth Street and understand what things worked in the street and what people felt required improvement. We were also wanting to confirm whether residents wanted to keep the garden bed in Market Place.

Residents wanted to keep the garden bed, they also wanted to see a lot more trees in the street to enable a more walkable and cooler environment. The railway line garden is managed by residents in the area, and it was noted that it would be beneficial to plant it out and create a green barrier to the train line.

4 responses were captured online with the following feedback:

Do you have any ideas or opportunities that you feel we should consider as part of the road rehabilitation in your street?


We didn't receive any comments online about issues or opportunities for Market Place and Thirteenth Street.

4.2 Concept Plan

A total of 10 responses were received throughout the concept consultation process from the 86 packages sent to the local community (Figure 1)



How could we improve the concept design?

The local community have petitioned for a greener more walkable street, and it was evident that in the feedback provided, the residents wanted additional trees, specifically Crepe Myrtle. It was also cited that respondents would like widened paths and to renew Gibson Street paths to walkable safe and a more walkable environment.

The garden along the train line is currently managed by the local community and it was requested at the WALKshop in December 2021 to allow more room for plantings to enable a green wall to be planted in the space.

A suggestion was also made to include additional trees in a number of specific locations to allow for tree canopy cover.
